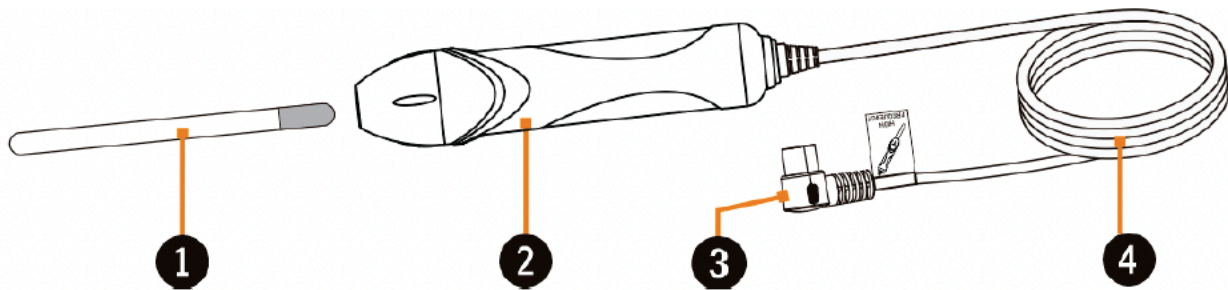

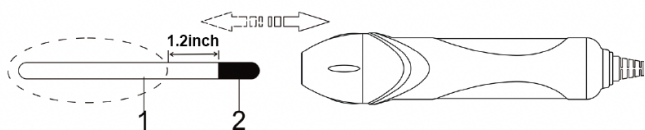

SELECTING THE RIGHT GLASS ELECTROTHERAPY TUBE FOR TREATMENT

1. **Mushroom-shaped Glass Electrotherapy Tube:** This tube is suitable for treating large areas such as the cheeks, forehead, and neck.
2. **Spoon-shaped Glass Electrotherapy Tube:** Ideal for medium-sized areas such as the chin.
3. **Dot Glass Electrotherapy Tube:** Designed for treating small areas like the nasal pit.

INTRODUCTION

The High Frequency Tabletop Facial Unit is a compact, professional-grade device designed for skin rejuvenation and therapeutic treatments.



This unit uses high-frequency currents to:

- Stimulate glandular activity.
- Enhance blood circulation.
- Provide germicidal and antibacterial effects.
- Promote deep product penetration.
- Gently warm the skin for relaxation and enhanced absorption of skincare products.
- This device is ideal for professional estheticians seeking to offer high-quality treatments with proven results.

HOW IT WORKS

High-frequency energy ionizes the gas inside the glass electrodes, creating ultraviolet rays and a glowing effect. This current stimulates the skin and provides therapeutic benefits.

OPERATING INSTRUCTIONS

INSTRUCTIONS FOR USE

Pre-Treatment Preparation

1. Remove all jewelry from both the esthetician and the client.
2. Ensure the client is not in contact with metal objects (e.g., the treatment chair frame).
3. Have the client remove contact lenses before treatment.
4. Explain the procedure to the client, including the sparking sensation they may feel.



Direct Technique (Soothing)

1. Apply a non-flammable, water-soluble product or gauze to the skin for slip. Avoid alcohol-based products.
2. Set the current intensity to its lowest setting before turning the unit "On."
3. Insert the chosen electrode into the handle, ensuring it is free of dust or debris.
4. Place your finger on the electrode, turn the unit "On," and position the electrode on the client's skin. Remove your finger from the electrode.
5. Adjust the intensity based on the client's comfort level.
6. Use small, circular movements starting from the neck and moving upward to the jaw, cheeks, nose, and forehead.



Indirect Technique (Soothing)

1. Have the client hold the straight electrode securely in both hands.
2. Cover the electrode with a gauze or cheesecloth for comfort.
3. Ensure the client maintains a firm grip before turning the unit "On."
4. Place one hand on the client's skin at the treatment area, then proceed with massage techniques.

MAINTENANCE AND CLEANING

1. **Cleaning Electrodes:** Use a non-alcoholic disinfectant and a damp cloth.
Do not immerse in liquid.
2. **Storage:** Store electrodes in a protective case to avoid damage.
3. **Maintenance:** Inspect all components regularly and replace damaged parts as needed.

TROUBLESHOOTING

Problem: Device Does Not Turn On

Ensure the power plug is securely connected to a functioning outlet.
Check the device's fuse or circuit breaker.

Problem: Electrode Does Not Glow

Verify that the electrode is inserted properly.
Test another electrode to rule out defects.

Problem: Sparking Is Weak

Clean the electrode with a soft cloth to remove any residue.
Check the intensity setting and adjust as needed.

WARNINGS

- Never use alcohol-based creams, toners, or masks during treatment.
- Do not direct the electrode towards the eyes.
- Avoid using damaged electrodes, as this may lead to skin injury.
- Only trained professionals should operate the device to ensure client safety.
