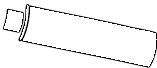
Specifications & Dimensions

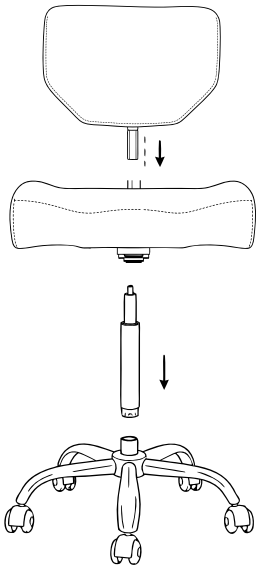
All measurements are in inches. Please allow a tolerance of 0.5" to 1".

Assembly Instructions

- 1. Make sure you have all the parts needed to assemble your chair.
- 2. Start by taking the hydraulic pump and placing it into the aluminum base.
- 3. Add the seat cushion on top of the hydraulic pump and sit on it to lock the spring into place.
- 4. Lastly, slide the neck of the backrest into the slot of the seat cushion and tighten the knob until it is secure.



Functions of the Chair



1. Backrest Tilt Adjustment Handle
2. Height Adjustment Handle
3. Seat Cushion Tilt Adjustment Handle
4. Backrest Height Knob
 - a. Loosen the knob, adjust the backrest to your preferred height, then tighten to lock into place.

Maintaining Your Chair

1. Wipe loose dust and debris off your chair with a dry towel.
2. Use a diluted sanitizing cleanser with a soft microfiber cloth to clean stains and marks off of the chair.
3. Caution: Using solvents including benzene, diluent, or gasoline will damage the leather and/or cause corrosion to the product. Avoid these solutions when cleaning.
4. Avoid storing or using the chair in high-moisture areas or direct sunlight for extended periods, as this may damage the upholstery, padding, and metal components.

Warnings

- Do not exceed maximum weight capacity.
- Use only on level flooring.
- Do not stand on the chair.
- Make sure all wheels and seat components are fully secured before use.
- Periodically inspect screws, wheels/casters, seat connection, backrest connection, and gas lift cylinder. Discontinue use if any component is loose, damaged, unstable, or not operating properly.
- Keep fingers, hair, and loose clothing away from moving parts during height, seat, or backrest adjustment.

Warranty Information

The manufacturer/warrantor warrants to the original purchaser that this product will be free from defects in materials and workmanship under normal and proper use for a period of one (1) year from the original date of purchase, unless otherwise stated in writing for a specific product.

This limited warranty applies only to the original purchaser and is not transferable. Proof of purchase may be required to obtain warranty service.

This warranty covers parts and labor required to correct defects in materials or workmanship during the warranty period. At the warrantor’s discretion, the product may be repaired, replaced, or substituted with a comparable item or component.

This warranty does not cover damage or defects caused by misuse, abuse, improper assembly, improper installation, unauthorized modification, unauthorized repair, neglect, accident, improper cleaning, use of harsh chemicals, power surges, water or liquid damage, use outside the intended purpose, failure to follow the product manual, or use with parts/accessories not approved by SkinAct.
