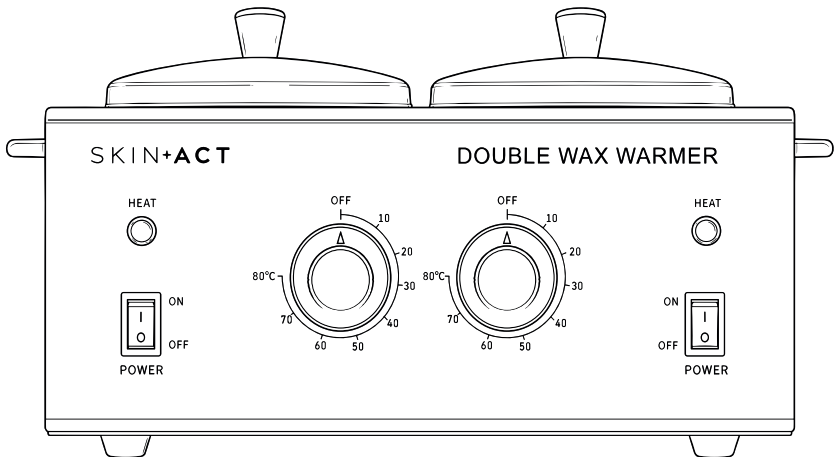

Contraindications and Client Screening

Do not perform a waxing service:

- On skin that is inflamed, infected, broken, irritated, burned, or sunburned.
- Over open wounds, sores, rashes, active skin eruptions, or swollen skin in the treatment area.
- On a client who is currently taking oral isotretinoin or who stopped taking it within the past six months, unless the client's healthcare provider has specifically approved waxing.
- On areas that have not fully healed following a chemical peel, laser treatment, dermabrasion, or another skin-resurfacing or intensive exfoliating treatment.

- If the client has a known allergy or sensitivity to the wax, fragrance, rosin, or any other ingredient in the wax product.

Conditions Requiring Additional Caution

Clients should consult a qualified healthcare professional before waxing if they:

- Take blood-thinning medication.
- Have diabetes, phlebitis, impaired circulation, or delayed wound healing.
- Have rosacea, fragile skin, or unusually sensitive skin.
- Use topical retinoids, prescription acne medications, antibiotics, exfoliating acids, or other products that may increase skin sensitivity.
- Are pregnant, taking hormonal birth control, or receiving hormone replacement therapy.

Burn Warning

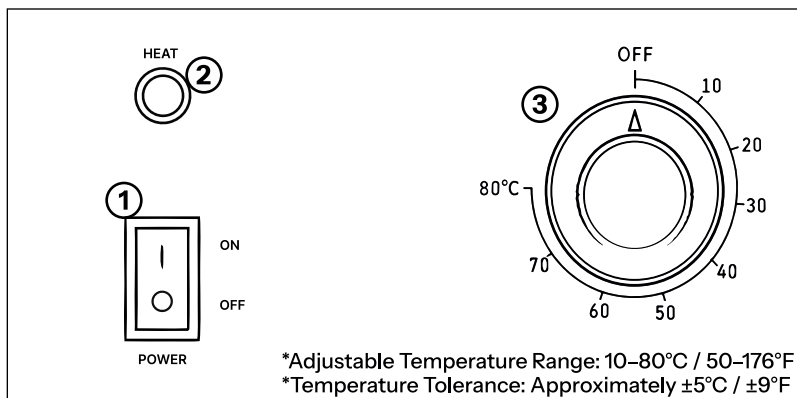
- Always test the wax temperature before applying it to the client. Wax that is runny may be too hot. The temperature-control dial indicates the warmer setting and should not be relied upon as the sole measurement of actual wax temperature. Always test the wax itself before application. Use a lower temperature on sensitive areas, including the face. Never apply wax that feels excessively hot or causes discomfort.
- Before performing a full waxing service, test the wax on a small area of intact skin. Discontinue use if excessive redness, burning, swelling, blistering, skin lifting, or another adverse reaction occurs.

Safety Precautions

- **For professional use only.**
- Read this manual completely before operating the unit.
- Use only professional depilatory or paraffin waxes that are compatible with this wax warmer.
- For indoor use only.
- Place the unit on a stable, level, heat-resistant surface.
- Unplug the warmer before cleaning, moving, or storing it.
- Verify that the power supply matches the voltage specified on the product label before use.
- Never double-dip an applicator. Use each disposable applicator once and discard it immediately.
- Discard wax that has been contaminated by skin contact, debris, used applicators, or improper handling.

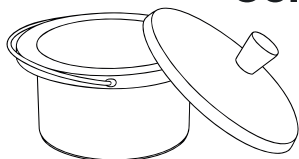
- Keep the unit away from water, excessive moisture, and other liquids.
- Do not operate the unit with wet hands.
- Never immerse the unit, power cord, or plug in water or any other liquid.
- Always unplug the unit before cleaning, servicing, moving, or when not in use.
- Do not use the unit if the power cord, plug, or housing is damaged.
- Do not attempt to disassemble, modify, or repair the unit. Repairs should only be performed by qualified service personnel.
- **HOT SURFACE:** The removable wax pots, lids, and surrounding surfaces become hot during operation.
- **Never leave the unit unattended while in operation or while heating wax.**
- **Do not leave the wax warmer operating overnight.**
- Always monitor the wax temperature throughout the heating process.
- Turn the unit OFF and unplug it when not in use.
- Do not operate a warming chamber without a properly installed removable wax pot or compatible wax can containing wax.
- Do not overfill the wax pots. Overflowing wax may damage the unit and create a burn hazard.
- Do not move the unit while the wax is hot or in a liquid state.
- Allow the unit and wax to cool completely before moving or storing.
- Keep the power cord away from heated surfaces and walkways where it may become damaged or create a tripping hazard.
- Keep out of reach of children and unauthorized persons.
- Do not use the unit near flammable materials, aerosol sprays, oxygen, or combustible vapors.
- If the unit emits smoke, unusual odors, or abnormal noises, immediately turn the unit OFF, unplug it, and discontinue use until inspected by qualified service personnel.
- Do not place hands, feet, or other body parts directly into the removable wax pot or warming chamber.
- There is no single correct temperature for every wax. Follow the wax manufacturer's recommended working temperature and reduce the warmer setting after the wax has fully melted.

Control Panel Overview

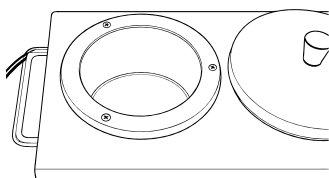


1. Power Switch

Compatible Wax Types



Removable Wax Pot: Use for hard wax, including wax beads, pellets, discs, blocks, or film wax.



Warming Chamber: Place one compatible 14-oz soft-wax can in each warming chamber, for a maximum total capacity of two cans or 28 oz. Compatible soft waxes may include honey wax, crème wax, or other professional strip-wax formulas.

Important: Do not pour wax directly into the warming chamber. Always use the removable wax pot or a compatible professional wax can.

Each side has an independent temperature control, allowing two compatible wax products to be heated at different temperatures. Always follow the wax manufacturer's heating instructions.

This wax warmer may be used with compatible professional depilatory wax or paraffin wax. Use each removable wax pot or compatible wax can for only one wax type at a time. Do not place hands or feet directly into this warmer. Do not mix depilatory wax and paraffin wax in the same container. Always follow the wax manufacturer's heating and application instructions.

Before First Use

- Remove all packaging materials and protective films.
- Inspect the unit for any visible damage before use.
- Wipe the removable wax pots and exterior with a soft, damp cloth.
- Ensure the unit is completely dry before plugging it into a power outlet.
- Perform a test heating cycle before the first client treatment to verify proper operation.

Operating Instructions

1. Connect the power cord to the unit's power socket, then plug it into a suitable 120 V AC electrical outlet.
2. Turn the power switch for the desired warming chamber to ON, then rotate the corresponding temperature control knob clockwise. The heating indicator light will illuminate while the unit is heating.
3. Use a higher setting only as needed to melt the wax, then reduce to the wax manufacturer's recommended holding/working temperature before client application.
4. During normal temperature regulation, the heating indicator may cycle on and off as the warmer maintains the selected temperature.

Professional Best Practices

- Inspect the client's skin before every waxing service.
- Test the wax temperature before each application.
- Follow the wax manufacturer's recommended heating temperature and usage instructions.
- Never double-dip applicators into the wax. Use a new applicator for each application to maintain proper hygiene. If contamination is suspected, discontinue use of the affected wax.
- Wear disposable gloves whenever required by your salon protocols or local regulations.
- Follow all applicable state board, local health department, and infection control guidelines.
- Keep the wax warmer clean and free of wax buildup.
- Stir the wax carefully before testing temperature so heat is distributed evenly. Always test before applying to the client.

- Replace wax immediately if contamination is suspected.
- Never mix incompatible wax formulations unless recommended by the wax manufacturer.

Cleaning & Maintenance

To maintain optimal performance and extend the life of your wax warmer, clean and inspect the unit regularly.

Cleaning Instructions:

1. Turn the power OFF, unplug the unit, and allow it to cool completely before cleaning.
2. While the remaining wax is still slightly warm, remove it using a wooden spatula or paper towel.
3. Wipe only the removable wax pots with a soft cloth dampened with warm water or an approved wax remover intended for professional waxing equipment.
4. Clean the exterior with a soft, damp cloth.
5. Dry all surfaces thoroughly before using the unit again.
6. Never immerse the unit, power cord, or plug in water or allow liquids to enter the electrical components.

Maintenance Guidelines:

- Clean the wax warmer after each use to prevent wax buildup.
- Do not use abrasive cleaners, steel wool, scouring pads, or harsh chemicals, as they may damage the stainless steel finish.
- Do not use metal tools or sharp objects to scrape hardened wax.
- Ensure the removable wax pots are completely dry before reheating wax.
- Inspect the power cord and plug regularly. Do not operate the unit if either is damaged.
- Avoid allowing wax to overflow into the warming chamber.
- **WARNING:** If wax spills into the warming chamber, unplug the unit immediately, allow it to cool completely, and carefully remove the wax before operating the unit again.
- Store the unit in a clean, dry location when not in use.

Important Maintenance

- Always unplug the unit before cleaning or performing maintenance.
- Never pour water directly into the removable wax pots or warming chambers.
- Never immerse the unit in water or any other liquid.
- Ensure the removable wax pots are completely dry before reheating wax.
- Ensure the unit is completely dry before reconnecting it to a power source.

Intended Use

This wax warmer is designed exclusively for heating professional depilatory wax or paraffin wax. Any use other than its intended purpose may result in equipment damage, product malfunction, or personal injury.
